The **Village of Goehner CDA** met in open session on August 2, 2022, at the Goehner Fire Hall, as posted in three places in the Village and published in the SCI on 7/20 & 7/27. Chairperson Knisley announced the location of the OPEN MEETINGS ACT POSTER. The meeting was called to order by Chairperson Knisley at 7:32 p.m., at the Goehner Fire Hall. Upon roll call, the following board members were present: Besse, Bialas, Agena and Knisley. Ostrander was absent.

1. Resolution 001 - approving (Redevelopment Plan)

The Village of **Goehner Board of Trustees** met in open and regular session on August 2, 2022, at the Goehner Fire Hall, as posted in three places in the Village. 1. Public Hearing on Blight and Substandard Designation

Motion to open the public hearing at 7:36 by Besse, seconded by Agena. RCV – Aye: Bessie, Agena, Bialas, Knisley.

Discussion: Keith Marvin & Mason Herman with Marvin Planning presented on the Blight and Substandard Study completed for the Village. State law requires a Blight & Substandard plan completed and adopted to qualify or use TIF funding. Marvin planning came to the village to take pictures of infrastructure concerns and looked at statistics from Assessors office to make the determination. State statute defines Blight as 40+ year old homes, lack of curbs, pooling of water, etc. Being in a Blight area, doesn't affect property values. The public study is used for state funding avenues. Once designation is made, it stays, even if infrastructure repairs are completed. Not condition of specific property.

2. **Resolution 265** declaring portion of Village Blighted and Substandard

3. Public Hearing on Redevelopment Plan

Motion to open the public hearing at 7:41 by Agena, seconded by Besse. RCV – Aye: Agena, Besse, Bialas, Knisley.

Discussion: Redevelopment Plan is 2-fold. 1. General plan for entire village and 2. private piece for Beck's Hybrid. Includes Village limits, ETJ and Beck's Hybrid. If approved, the benefit to the Village with TIF funding for future projects. Amendments would be made to the current plan and can be modified via public hearing. (Appendix A). This is in a line with the current Comprehensive Plan the village has in place.

Every time TIF is used, there is a cost/benefit analysis.

Agricultural facility has certain criteria, it permits "skip annexation". Criteria are a plant where value is added to agricultural commodities, more than 80% of sales not to direct consumers, investment is over \$1M. The assessors value is 8.3mil when complete and will get 1.9mil in TIF over 15 years. (Grading, acquisition, legal fees, etc. are qualified). Would like to complete by end of 2023 and TIF would begin 2024 if needed. No zoning changes will occur, and all permitting is the same a normal project regardless of TIF. Cost benefit analysis – \$126,000 per year for 15 years.

Beck's is bringing "Data" and scientific research, which is their value-added commodity, project exceeds \$9M in value.

Caleb Bruner shared information about Beck's and introduced their employees here in the area. Introduced Keen employees as well. What makes Beck's different than the competitors is their customer service.

4. Third Reading and Public Hearing on Annexation

The Annexation Ordinance requires three readings before being passed. Chairperson Knisley read Ordinance 261 for the third and final time on 8/2/22.

Discussion: Village won't extend services, isn't adjacent. State statue protects it.

- 12. Solid Waste/Recycling no update until September 15th meeting
- 13. Street, Water, Sewer Report
 - a. Water concerns at Chez Bubba. Matt shared how the water pressure is running at best 15 psi which is too low to run our ice machine and often too low to run water for more than one thing at a time, e.g. wash hands and flush a toilet. We've done everything we can think of on our end to fix this and have not seen any improvement. Per the quality issue, since the storms on June 14th, we have experienced significant spoilage of anything we cook using Goehner water. Mashed potatoes, gravy, beans, made with Goehner water spoil in 24 hours. We've resorted to using distilled water that we have purchased at the store to avoid throwing out food. We are concerned that something may have happened to the water during the storm and become contaminated in some way. Based on all our food safety reference materials it appears to be bacterial. The only common thing we have not been able to eliminate as a cause of this is the use of Goehner water.
 - b. Working on alleys now, they look good
 - c. Rural water Mike Standfall was here today. North well wouldn't shut off yesterday, village is using too much water and the wells won't keep up.
 - d. Janice had Eric Cox out last Friday to review current water issues. The filter at Chez is blocking up and backing up into the restaurant. George to dig up curb stop to see if that helps with quality.
 - e. ARPA funding is still available. Contact Misty Ahmic (county commissioner) to see what needs to be done to apply for funding.
 - f. Water restrictions are needed during this time.

Motion to begin water restrictions effective immediately. Odd number houses on odd days, even number houses on even days until further notice by Ostrander, seconded by Bialas. RCV: Ostrander, Bialas, Agena, Besse, Knisley. Motion carried.
