<p><b>The following is part of the Village of Goehner Ordinances and is subject to change. It should be used as a reference. For the full ordinance, refer to the official codified code book with the most recently passed ordinances in effect.</b></p> <p><b>§113.01 Definitions:</b></p> <p><b>Itinerant Merchant.</b> Any person, whether as owner, agent, or consignee, who engages in a temporary business of selling goods within the village and who, in the furtherance of that business, uses any building, structure, vehicle, or any place within the village.</p> <p><b>Peddler.</b> Any person, not an itinerant merchant who:</p> <ol style="list-style-type: none"> <li>1. Travels from place to place by any means carrying goods for sale, making sales, or making deliveries; or</li> <li>2. Without traveling from place to place, sells or offers goods for sale from any public place within the village.</li> </ol> <p><b>Solicitor.</b> Any person who travels by any means from place to place, taking or attempting to take orders for sale of goods to be delivered in the future or for services to be performed in the future. A person who is a solicitor is not a peddler.</p>

**§113.02 License Required.**

- A. Any person who is an itinerant merchant, peddler, or solicitor shall obtain a license before engaging in that activity within the village.
- B. The fee shall be set by the Village.
- C. No license issue shall be transferable.
- D. All licenses shall expire 90 days after date of issuance. **Penalty \$10.99**

**§113.06 Standards for Revocation**

A license granted under this chapter may be revoked for any of the following reasons:

- A. Fraud or misrepresentation contained in license application
- B. Any fraud, misrepresentation, or false statement made in connection with the business being conducted under the license
- C. Any violation of this chapter
- D. Conviction of the license of any felony, or conviction of the licensee or any misdemeanor involving moral turpitude or
- E. Conducting the business licensed in an unlawful manner or in such a way as to constitute a menace to the health, safety, morals, or general welfare of the public

**§113.08 Exhibition of Identification**

- A. Any license issued to an itinerant merchant under this chapter shall be posted conspicuously in or at the place named therein. In the event more than 1 place within the village shall be used to conduct the business licensed, separate licenses shall be issued for each place.
- B. The Clerk-Treasurer shall issue a license to each peddler or solicitor licensed under this chapter. The license shall be kept with the licensee during the time that he or she is engaged in the business licensed. **Penalty \$10.99**

**§113.09 Policy on Soliciting**

It is hereby declared to be the policy of the village that the occupants of the residences in the village shall make the determination of whether solicitors shall be, or shall not be, invited to their respective residences.

**§113.11** . . If the notice states “**NO SOLICITORS INVITED,**” then the solicitor, whether registered or not, shall immediately and peacefully depart from the premises. **Any solicitor who has gained entrance to any residence, whether invited or not, shall immediately and peacefully depart from the premises when requested to do so by the occupant.** **Penalty \$10.99**

**§10.99 General Penalty.** Any person who violates any of the provisions of this village code, unless otherwise specifically provided herein, shall be deemed guilty of an offense and upon conviction thereof shall be fined in any sum not exceeding **\$500**. A new violation shall be deemed to have been committed every 24 hours of failure to comply with the provisions of the code.

The applicant will hold the Village of Goehner harmless from any and all liability which may result from the performance of the activities arising out of this application. The applicant will limit the hours of sale from 9:00 a.m. to 8:00 p.m.
