January 14, 2025

The Village of Goehner Board of Trustees met in open session and regular session on January 14, 2025, at the Goehner Fire Hall, as posted in three places in the Village. Chairperson Knisley announced the location of the OPEN MEETINGS ACT POSTER. The meeting was called to order by Chairperson Knisley at 7:30 p.m., at the Goehner Fire Hall. Upon roll call, the following board members were present: Agena, Anthony, Ostrander, Bialas and Knisley.

CONSENT AGENDA: Minutes of 12/03/2024; Treasurer's Report; Bills payable to date. Trustee Ostrander moved to approve the consent agenda, with a second by Trustee Agena. No discussion. RCV: Aye - Trustees Ostrander, Agena, Anthony, Bialas and Knisley. Motion Carried.

Zoning Inspector Report - None

Nuisance properties – Check with Tim Dworak in Seward regarding property that needs to be inspected for abandoned properties. Send letter to Village resident regarding unlicensed vehicles and running business in residential area.

Traffic Report – County Sheriff emailed to trustee's. Will request to have deputy at next meeting.

Sex Offender registry – Will check with lawyer regarding new ordinance.

Solid Waste/Recycling – Next meeting is January 30th.

Street, Water, Sewer:

- Report was given by the water superintendent regarding the reason the water within the Village needs to be chlorinated right now. Chlorination was State mandated and will be done for 30 days. This was due to water sample in December coming back from lab with high Total Coliform. The State representative came to the Village to inspect the water system and said the test sites used were causing the problem because water was not flushed through pipes for a long enough time before taking the sample. Will be looking for alternative sites to test Village water from.
- Hold off on sample sites to be installed through out the Village.
- Check with Eric Cox our State Representative regarding the pipes set up within the South Wellhouse. Check if the pipes are okay or if they will require being fixed.
- Stop signs and yield signs in a couple of locations in the Village need to be replaced, will order new signs. Need to check number of street signs for next month to order new signs for streets.

Clerk report – Move February meeting to the 11th. Request of credit card for use by Village employee's to pay for supplies and postage and not have to pay out of pocket and wait for reimbursement. Motion was made by Trustee Ostrander to allow Village Treasurer to apply for Credit card with a second by Trustee Agena. No discussion. RCV: Aye - Trustees Ostrander, Agena, Anthony, Bialas and Knisley. Motion Carried.
